The following Contest Rules apply to the Niagara's Finest Hotels' Niagara Getaway Contest (the "Contest") sponsored by Lais Hotel Properties Limited o/a "Lais Hotel Properties Limited" ("Lais Hotel Properties Limited"). By entering into the Contest, Entrants agree to be bound by the following contest rules (the "Contest Rules").

1. **ELIGIBILITY:** The Contest is open to all legal residents of Canada who are at least eighteen (18) years of age or older as of the first day of the Contest Period. Notwithstanding the above, the Contest is not open to individuals associated with the Contest, including the employees, agents or representatives of Lais Hotel Properties Limited and suppliers providing prizes or other materials or services in connection with the Contest (collectively, the "Excluded Individuals"). This Contest is also not open to the immediate family members of the Excluded Individuals, and all other persons with whom the Excluded Individuals reside.

2. **CONTEST PERIOD:** Starting on 12:01 a.m., Eastern Time, April 1st, 2019, to 11:59 p.m., Eastern Time April 28th, 2019, (the "Contest Period") Entrants may participate in the Contest.

3. **HOW TO ENTER:** Entrants may participate in the Contest by completing the online entry form. Submissions may be made online at https://www.niagarasfinest.com/chfi_contest.php. Upon completion and receipt of the Submission, eligible Entrants will be entered into the Contest for one (1) chance to win the Prizes.

Entrants are restricted to one (1) Submission per person, per household during the Contest Period. Submissions indicating the same telephone contact number or address will be considered, for purposes of the Contest, to belong to the same Entrant and therefore are subject to the above restriction. Any excess submissions will be invalid for purposes of the Contest.

4. **NO PURCHASE NECESSARY:** No purchase is required to enter the Contest.

5. **AWARDING OF PRIZES:** The Grand Prize will be awarded on May 1, 2019, to the Entrant whose contact information (name, telephone number or email address) has been given with the winning Submission.

The Entrants with the winning Submissions will be contacted by phone or mail (using the contact information provided by the Entrant with their Submission) by May 3, 2019. If the selected Entrants with the winning Submissions cannot be contacted in that time, another Submission will be selected and the initial selected Entrant will be disqualified and will have no recourse towards Lais Hotel Properties Limited or anyone involved in the Contest. GENERAL

Lais Hotel Properties Limited reserves the right, at its sole discretion and without prior notice, to amend, cancel, close, suspend or reinstate the Contest at any time and for any reason whatsoever. Lais Hotel Properties Limited reserves the right, in its sole discretion, to cancel or substitute any component of a Prize for its cash value or a prize of approximately the same retail value. Prizes are non-transferable, must be accepted as awarded by Lais Hotel Properties Limited and cannot be exchanged by a declared winner for cash or other substitutes.
